

State of Illinois Directory of Compliant NPMs

This Directory lists all Non-participating Manufacturers and brand families that are certified as being in compliance with the Tobacco Products Manufacturers' Escrow Enforcement Act of 2003 and the Cigarette Fire Safety Standard Act. ONLY cigarette brands and roll-your-own (RYO) tobacco products listed on this Directory or on the Directory of Participating Manufacturers may be sold, offered or possessed for sale in Illinois. In order to be lawfully sold in the State of Illinois, both the NPM and the brand must appear together on this list.

Effective January 1, 2008, the Cigarette Fire Safety Standard Act (425 ILCS 8/1 *et seq.*) provides that no cigarettes shall be sold or offered for sale to any person in Illinois unless they are certified and approved as in compliance with the Act. The Act does not apply to RYO tobacco products.

Effective September 22, 2009, pursuant to Section 907(a)(1)(A) of the Federal Food, Drug and Cosmetic Act as amended by the Family Smoking Prevention and Tobacco Control Act, a cigarette or any of its component parts (including the tobacco, filter or paper) shall not contain, as a constituent (including a smoke constituent) or additive, an artificial or natural flavor (other than tobacco or menthol) or an herb or spice, including strawberry, grape, orange, clove, cinnamon, pineapple, vanilla, coconut, licorice, cocoa, chocolate, cherry or coffee, that is a characterizing flavor of the tobacco product or tobacco smoke. According to the FDA, cigarettes and their component parts that fail to comply with the special rule established under section 907 are deemed adulterated under section 902 and as such are subject to seizure under section 304 as well as other enforcement action under the Federal Food, Drug and Cosmetic Act. Roll-you-own tobacco products are listed on the Directory by brand family, not by brand style. Some styles of RYO brand families which are listed on the Directory may contain certain characterizing flavors and as such may be deemed adulterated as provided above.

The Office of the Attorney General may periodically update this directory by either adding or removing brand families and/or non-participating manufacturers or making adjustments as requested by the Fire Marshal.
